Admission to the MD, Psychiatry course at LGBRIMH - 2020 session

Stray Vacancy Round for the eligible candidates listed for 'Central Institute for Stray Vacancy (Medical)' (available on MCC website) will be held on 31/07/2020 in the Cafeteria Block, LGBRIMH at 2 PM for the admission to the following number of candidates of MD, Psychiatry. Eligible candidates who are listed as per the MCC website (www.mcc.nic.in) can apply ONLY.

MD (Psychiatry): 02 Seats (01 - UR, 01 - OBC).

As per the directive vide Ref no – F. No U-12021 /44/2019–MEC, dated 27/07/2020, from office of ADG(ME), Govt. of India, DGHS, New Delhi, the candidates for stray Vacancy Round at LGBRIMH should be selected from the list forwarded by MCC and admission should be made strictly in terms of merit.

As per the notice vide no- U12021/44/2019/72-MEC, dated 27/07/2020 from the office of ADG(ME), Govt. of India, DGHS, New Delhi, the following candidates will be 'Eligible' for Stray Vacancy Round:

- 1. Candidates who are registered with MCC (name of candidate appearing in the list forwarded by MCC) and are not holding any seat.
- 2. Candidates who have not been Allotted a seat in Mop Up Round.

The following candidates will **NOT** be '**Eligible**' for Stray Vacancy Round:

- 1. Candidates who were allotted a seat in Mop Up Round but did not report at the Allotted Institute are 'Not Eligible' to participate in Stray Vacancy Round.
- 2. Joined candidates of previous rounds.
- 3. Candidates not 'REGISTERED' on MCC website.

Therefore, eligible candidates are directed to report physically with all the following 'ORIGINAL DOCCUMENTS' at 1 PM on 31/07/2020 at Cafeteria Block (1ST Floor), LGBRIMH for the Stray Vacancy Round Admission Counseling.

The following original documents are required for verification by the College authorities during the physical reporting process of Stray Vacancy Round:

- i. Admit Card issued by NBE
- ii. Result/Rank Letter issued by NBE
- iii. Registration slip/ Document of Mop-Up/Stray vacancy round for Central Institute 2020.
- iv. Mark Sheets of MBBS/BDS 1st, 2nd & 3rd Professional Examinations.
- v. MBBS/BDS Degree Certificate/Provisional Certificate.
- v. Internship Completion Certificate/Certificate from the Head of Institution or College that the candidate shall complete the Internship by 31st March, of the year of admission.
- vi. Permanent / provisional Registration Certificate issued by MCI or DCI/State Medical or Dental Council. Provisional Registration Certificate is acceptable only in cases where candidate is undergoing internship and likely to complete the same on or before 31st March of the year of admission.
- vii. Class 12th marksheet.
- viii. High School/Higher Secondary Certificate/Birth Certificate as proof of date or birth.
- ix. Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for AIPGMEE/AIPGDEE i.e. PAN Card, Driving License, Voter ID, Passport or Aadhar Card).
- x. The Candidate should also bring/upload the following certificates, if applicable
 - a) SC/ST Certificate issued by the competent authority and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate.

- b) OBC certificate issued by the competent authority. The sub-caste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer. The OBC certificate must be in the format as mentioned in the prospectus.
- c) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act,2016. No other PwD certificate, issued by any other Authorities/ Hospital will be entertained.
