Essential Qualification for Assistant Professor of Psychiatry: i)A recognized medical qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).ii) Post graduate degree in the concerned specialty or Super-specialty mentioned in section-A of scheduled VI iii) least three years' experience At Lecturer/Tutor/Registrar/Demonstrator Senior Resident in the concerned specialty in a recognized teaching institution after obtaining the first post-graduate degree.

Note 1.- Doctorate of Medicine (DM) of three years' duration shall be counted towards requirement of teaching experience.

Note 2:- Doctorate of Medicine (D.M.) of five years' duration, shall be taken as three years for completion of post graduate degree and the last two years of the said Doctorate of Medicine (D.M.) shall be counted towards requirement of teaching experience.

Note 3. Teaching experience in any other post like the post of General Duty Medical Officer or Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

Note 4. DM degree holders of Geriatric Mental Health /Child & Adolescent Psychiatry will be given preference.

Essential Qualification for Psychiatric Nursing: (i) Master's Degree in Psychiatric Nursing (ii) Ph. D in Psychiatric Nursing from a recognized Institution / University. Essential Experience: Three years of teaching/clinical/research experience after Ph.D degree.

Essential Qualification for Psychiatric Social Work: (i) Master's Degree in Social Work (ii) M.Phil in Psychiatric Social Work or equivalent qualification from a recognized Institution. (iii)Ph. D in Psychiatric Social Work from a recognized Institution/ University. Essential Experience: Three years teaching /clinical /research experience in the concerned subject after Ph.D degree.

Essential Qualification for Statistician cum Lecturer: (i) Master's Degree in statistics or Mathematics with Statistics as additional subject or allied subject. (ii) PhD in Biostatistics or any equivalent from a recognized university. (iii) 2 years' experience of data processing and statistical work in any Institution/ University preferably in a medical college/ Institution.

Essential Qualification for Speech Therapist: B.Sc. (Hons) in speech Pathology & Audiology or equivalent qualification from a recognized University/Institution. Desirable: 2 years Experience in the field of Speech Pathology in Neuro- Psychiatric disorder in a psychiatric hospital of Central/State/Semi Govt. organization.

Terms & Conditions For Contract Appointment For the above mentioned posts

- 1. The appointment is purely on full time CONTRACT BASIS for a period of 03 months with effect from the date of joining which may be further extended as per functional requirement of the Institute; or till such time the regular arrangements are being made, whichever is earlier. If the contract is not extended further, the same will lapse automatically. The appointment may be terminated at any time, giving one month's notice or by paying one month's salary by the appointee or failure to complete the period of three months to the satisfaction of competent authority. However, the Competent Authority reserves the right to terminate forthwith without assigning any reason thereof.
- 2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- 3. The appointee shall not be entitled to any other benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
- 4. The appointee shall not have any claim or rights for regular appointment to any post at LGBRIMH.
- 5. The appointee shall be on the whole time appointment of the LGBRIMH and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.

- 6. On appointment, the appointee will be required to take an Oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma. Also, they will have to sign on Deed of Agreement.
- 7. Other terms and conditions of service which are not specifically mentioned herein will be governed by relevant rules and orders issued from time to time.
- 8. Interview will be through off line / online mode. For Registration eligible candidates are requested to e-mail necessary documents (all relevant original testimonials/BIO-DATA, attested copies of certificate/ one PP size photograph) to institute e.mail id lgbrimh@yahoo.co.in from 9.00 a.m. to 12. 00 p.m. with preference of appearance online/offline on 13/07/2022.
- 9. If any declaration given or information furnished by him/her proves to be false or if he /she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
