The rate should be quoted both in figure and words. Any corrections made should be authenticated. Use of whitener is strictly unacceptable.

A. Technical Quatation

The following documents have to be provided along with the technical Quotation:

- i. Provide Profile of Firm/Company/ organization as per annexure-I
- ii. EMD of Rs. 1000.00 in the form of DD/FDR/BG in favor of Director, LGBRIMH, Tezpur payable at Tezpur, Sonitpur, Assam or proof of EMD exemption should be submitted.
- iii. Annual turnover of the bidder for the last 3 Years from Chartered Accountants should be submitted.
- iv. Names & addresses (at least three) in Govt/ Semi-govt./Autonomous institution along with the telephone numbers of the contact persons of the clients to whom similar Quality assurance test provided by your firm/organization etc. Documentary evidence shall produce from such institution.
- v. Recent non-conviction/ non-blacklisting certificate on non-judicial stamp paper of worth Rs. 100.00 duly attested by Notary Public (As per annexure II) should be submitted.
- vi. Updated Income Tax return documents for the financial year 2020-21 should be submitted.
- vii. PAN Card and GST registration certificate should be submitted.

B. General Terms & Conditions:

- i. Technical and Financial Quotation should be submitted on company letter head and should be submitted duly signed by the authorized person.

- ix. In case of any dispute the same shall be mitigated as per provision of the tender and territorial jurisdiction shall be within the limit of the Tezpur District Court.

C. Scope of Work

- 1. The quality assurance of each Equipments will be done as strictly as per the AERB prescribe norms and guidelines at the approved rate only
- 2. The quality assurance will be done by only AERB authorized quality assurance person
- 3. The Quality test of the Equipments will be done at the LGBRIMH, Tezpur premises only.
- 4. The kit/tools required for carrying out QA to these Equipments will be arranged by bidder himself
- 5. The quality assurance test will be done on mutually agreed date of the concerned department and with minimum hampering of the hospital work.
- 6. No alteration/modification of any type is allowed in any Equipments
- 7. The quality assurance test report will be submitted within seven days after signature of concerned Head of the Department.

D. Safety precaution

- 1. It is the responsibility of the contractor that the quality assurance of the equipment is user friendly i.e there should not be any hazard/leakage of radiation/electicity to the user and the Patient.
- 2. LGBRIMH, Tezpur will not be under any liability to pay any compensation to the persons/engineers deployed by the contractor if they sustain any injury etc while discharging the duties in the premises. Any damages caused to the building/premises during the execution of work shall be made repair by the contractor.

E. Human Resources

1. The Manpower deployed by the contractor should be polite, positive and efficient, while handling the work of these equipments. No additional payment shall be made if more staff needed at site for completing the work. The representative of the firm should bring their Identity Cards while attending to the job in hospital.

F. EMD/ PERFORMANCE SECURITY

- a) Bidder should submit EMD of Rs. 1000.00 in the form of DD/FDR/BG drawn in favor of Director, LGBRIMH, Tezpur, Assam, payable at Tezpur, Sonitpur, Assam failing which the quoation shall not be considered for acceptance and will be summarily rejected.
