Essential Qualifications and experience for the post of Publication Officer: (i) Bachelor's Degree in Science/Arts (ii) PG Diploma in Journalism OR Master's Degree in Mass Communication & Journalism from a recognized University/Institution. Desirable: 3 years working experience in the field of Medical & Scientific journals.

Essential Qualifications and experience for the post of Publication Assistant: Bachelor's Degree in any discipline from a recognized University with at least 3 years experience in proof reading of technical literature/science journals in a reputed publishing house. Desirable: Proficiency in English language. Knowledge of production aspects of science publication. Diploma in Journalism/Printing.

GENERAL CONDITIONS

- 1. Candidates who do not fulfill requirements as per advertisement need not apply.

- 10. For posts having experience as an Essential criterion, the experience which has been acquired only after obtaining Essential Qualification, will be considered as valid.
