Applications are invited (Online/Offline) with all relevant testimonials from eligible candidates for One (01) Year Post Doctoral Fellowship / Fellowship Courses commencing in Session 2026 at LGB Regional Institute of Mental Health (LGBRIMH), Tezpur, Assam, an Autonomous Body under the Ministry of Health & Family Welfare, Government of India. The courses are conducted under the departments detailed below. Selection shall be through merit-based evaluation and Interview (Hybrid Mode — in-person / online).

**2. ELIGIBILITY CRITERIA**

4	Community Mental Health Nursing (Fellowship)	M.Sc. Nursing from a recognized University / Institution as per INC norms. Candidates must possess a valid Nursing registration.

### **3. COURSE DURATION**

The duration of Post Doctoral Fellowship / Fellowship Course shall be ONE (01) YEAR (Non-extendable), as prescribed by the respective Regulatory Bodies.

### **4. AGE LIMIT**

(a) **Maximum Age:** 45 (Forty-Five) years as on the last date of receipt of application.

(b) **Age Relaxation:** Sponsored/In-service candidates shall be eligible for age relaxation as per the extant orders and norms of the Government of India applicable to in-service personnel.

### **6. SELECTION PROCESS**

Selection shall be made on the basis of Academic Merit and Personal Interview (Hybrid Mode — in-person or online as per Institute decision). Mere fulfilment of eligibility criteria shall not confer any right to be called for interview or to be selected.

- Candidates will be shortlisted based on academic record, research publications, and relevant experience.
- Final merit list shall be prepared by the duly constituted Selection Committee of the Institute.
- The Institute reserves the right to fix cut-off criteria for shortlisting candidates for interview.

3. Degree Certificate(s) — MBBS / MD / DNB / M.Sc. Nursing (as applicable).
4. Valid Registration Certificate issued by MCI/NMC / State Medical Council / State Nursing Council (as applicable).
5. Experience Certificates (if any), issued by competent authority.
6. Category Certificate: SC/ST/OBC/EWS — issued by competent authority (if claiming reservation/relaxation).
7. No Objection Certificate (NOC) from the employer — MANDATORY for Sponsored/In-service candidates, duly signed and stamped by the Head of Institution/Competent Authority.
8. Sponsorship Letter from employer clearly stating willingness to grant leave for the entire duration of the course — for sponsored candidates.
9. Government-issued Photo Identity Proof (Aadhaar Card / Voter ID / Passport / PAN Card).
10. Domicile/Nativity Certificate — for candidates applying under North-Eastern States Sponsored category.
11. Two (02) recent passport-size photographs (self-attested).
12. Any other relevant certificate/document.
